THIS MEMORANDUM OF UNDERSTANDING IS MADE BETWEEN

K.L. Mehta Dayanand College for Women-Faridabad, Haryana-121001, Accredited with B⁺⁺ Grade by NAAC, Affiliated to M. D. University, (Rohtak) NH 3, N.I.T. Faridabad, Haryana, Tel.: 0129-2416602, Website: www.klmehtadcw.org represented by its **Principal here in after referred as 'First Party', the institution whose expression, unless excluded by or repugnant to the subject or context shall include its successors—in-office, administrators and assigns.**

And

YOUTH FOR SEVA, 75,76, 4th Cross, 2nd Main Soudamini Layout , Konanakunte, Bangalore – 560 062, represented by its Chief Mentor & Founder, Sri. Venkatesh Murthy, hereinafter referred to as “Second Party”, the NGO whose expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns.

Both organisations are linked by inspiring youth to volunteer, and provides them with meaningful opportunities to serve the community. The activities undertaken pursuant to this Linkage are based on a spirit of cooperation and reciprocity that is intended to be of mutual benefit to both parties.

This MOU aims to create positive change agents in the society, through the culture of volunteering.

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS.

I. Scope of this MoU

1. Cooperation: Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within their related constituents. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

General terms of co-operation shall be governed by this MOU.

The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the ‘Definitive Documents’) as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

2. NMMS: The National Means cum Merit Scholarship Examination, also known as NMMS Exam, is sponsored by the Central Government. The examination is conducted by the local authority. To prevent the dropping out of economically backward students from school at class VIII and to encourage them to complete their education till the secondary stage, the exam seeks to identify meritorious students and fund their education expenses.

K.L. Mehta Dayanand College for Women-Faridabad, Haryana-121001 shall encourage and enroll at least 10 (ten) students to volunteer for six (6) hours and three (3) days in a week over a period of three (3) Months during every calendar year (August-November).

3. "Navoudit " (Newly risen) is a flagship annual event by Youth for Seva created to bring out the artist in every child. It provides a strong and unique platform for students from Government schools and learning centres to showcase their inbuilt talents in various forms of arts and culture. KL Mehta Dayanand College of Women, Faridabad will co-host Navodit through 5 (Five) student volunteers as organizers of the event with campus space (auditorium or playground) for government school children to exhibit their talent. Also, other volunteers will be engaged in training of participants, planning and managing (Decoration, food distribution, anchoring) of Navoudit and volunteers will be spending their time with children, sharing knowledge, helping in improving skills while they take back a true experience of the joy in giving. Navodit is a great platform for volunteers to understand the importance of being empathetic, considerate and supportive towards the under-privileged sections of the society.

4. **Volunteer Base and Internship:** A volunteer base of not less than 4 (four) regular student volunteers and a faculty mentor/supervisor under the Youth for Seva forum/club will be formed to render volunteering service. Student volunteers will participate in the YFS volunteer service activities as and when requested, based on the need for volunteer support required to address social issues or social developmental activities. Not less than twenty (20) students will take up a full time internship program with youth for seva for a duration of not less than 1 (one) Month during every calendar year. Students will be eligible for certification after completing at least 50 hours of service in Youth For Seva.

5. **Joint Publications.** Joint publications of research articles, papers, books to develop research aptitude and to contribute to the world of knowledge concerning volunteerism and community will be taken by both the parties.

6. **Joint Holding of Conference / Seminar / Workshop / Training / Symposia concerning volunteerism and community service, etc:** Joint organization of conferences / workshops / seminars / symposia / summer schools / training / lectures, etc to improve the exchange of knowledge and experience.

7. Exchange of Knowledge Resources. Share books, journals and teaching materials including textbooks, audio-videos, publications, reports and other teaching aids pertaining to volunteerism and community service.

8. Seminars/Awareness Sessions: We together will organize awareness sessions under different domains of education, health, environment and livelihood for the student volunteers and for different underprivileged communities for societal upliftment.

9. Employability readiness program (ERP): YFS will conduct employability skill development sessions for the college in collaboration with various different MNCs in which we will cover the topics of Interview facing, effective CV writing, personal branding etc. These sessions will support the students to upskill themselves in professional terms.

II. FINANCIAL COMMITMENTS.

There is no financial commitment on the part of the **K.L. Mehta Dayanand College for Women-Faridabad, Haryana-121001**, the First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately. Similarly, there are no financial or monetary commitments on the part of the **YOUTH FOR SEVA- NGO** the Second Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

III. INTELLECTUAL PROPERTY

Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property of the other Party.

IV. AMENDMENTS TO THE MOU:

No amendment or modification of this MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be an amendment of this MoU. The modifications / changes shall be effective from the date on which they are made / executed unless otherwise agreed to.

V. ASSIGNMENT OF THE MOU:

The rights or / and liabilities arising to any part of this MoU shall not be assigned except with the written consent of the other party and subject to such terms and conditions as may be agreed upon between the involved parties.

VI. DISPUTE RESOLUTION.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District HeadQuarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of Gadag/Bangalore.

VII. VALIDITY

This MoU will last for one year from the day of agreement.


