## **CODE OF CONDUCT**

1. It is mandatory for the students to carry their ID card daily & must wear it.
2. The college lays special emphasis on the maintenance of discipline and proper decorum in and outside the classrooms. Students will be rusticated if found involved in any kind of indiscipline.
3. Students are not supposed to roam about in corridors when classes are going on.
4. Students must make it a habit to read the Notice Board / display board daily.
5. Disorderly conduct, shouting in the verandahs, damaging the college property shall be severely dealt with.
6. It is the moral duty of the students to show due respect to their teachers and elders. They are expected to be polite to the office staff, peons and guests and extend them all possible help.
7. Students are expected to attend all classes very regularly and punctually. The students will not be given attendance if late in Class.
8. No meeting of the students will be held in college campus without prior approval of the Principal.
9. Students leaving the classroom without the permission of teacher shall be penalised.
10. Students taking part in anti-college / immoral activities will be suspended from the college.
11. As per the decision of the Haryana Government, which the colleges have been asked to comply with strictly, students are not allowed to use mobile phones College Campus.
12. The college gate will remain closed till 1.00 p.m. (Depending upon Covid situation)
13. Parents are encouraged to visit the College frequently & meet the concerned lecturers to enquire about the progress of their wards. Last Saturday of the month will be parent teacher meeting. (Depending upon Covid situation)
14. It is appreciable for all students to attend the "Morning Prayer" at 9.00 a.m.
15. It is compulsory for all students to appear in Mid-Semester exams in every semester.
16. Students with less than 75% attendance and those who do not appear in Mid-semester exams will not be allowed to appear in University exams.
17. As per University rule, Tests and Assignments are mandatory.
18. Students will not be allowed to park cars inside the Campus.
19. Any student who remains absent from house examination for Medical reasons will have to submit 'Medical certificate' issued by Govt. Hospitals within three days.
20. Ragging is strictly prohibited in college premises, students who will involve themselves in ragging activities will be fined or punished.
21. It is mandatory for the students using two wheelers to wear helmet.
22. Students should use the canteen area for refreshment purpose only.
23. Each student should have e-mail ID and Bank Account.
24. Students are required to maintain decorum of educational institute while dressing up.

**शिक्षण संस्थाओं में रैगिंग पर प्रतिबंध**

सुप्रीम कोर्ट के एक निर्णय के अनुसार UGC द्वारा अपने पत्र संख्या FA-/97 (CPP-II) दिनांक 7 जुलाई, 2001 द्वारा रैगिंग पर रोक लगाने के लिए निम्न आदेश सख्ती से पालन हेतु जारी किए गए।

शिक्षण संस्थाओं में रैगिंग पर प्रतिबंध लगा दिया गया है और यदि कोई रैगिंग में शामिल पाया जाता है या लिप्त होने की संभावना है तो उचित सजा के अंतर्गत निम्न रूप में दंडित किया जा सकता है।

- (i) संस्थान से निष्कासन
- (ii) संस्थान से या कक्षा से सिमित अवधि के लिए निष्कासन या सार्वजनिक रूप से माफी
- (iii) छात्रवृत्ति या अन्य लाभों पर रोक
- (iv) संस्था में प्रतिनिधित्व गतिविधियों पर रोक
- (v) परिणाम पर रोक
- (vi) होस्टल या मैस से निलंबन या निष्कासन
- (vii) स्थानीय पुलिस स्टेशन में FIR दर्ज
- (viii) यदि कोई रैगिंग करने या कराने के लिए उकसाने के लिए नहीं पहचाना जाता तो सामूहिक रूप से दंडित करना

**निम्न व्यवहार रैगिंग की सीमा में आते हैं**

किसी भी प्रकार का उत्तुंखल आचरण चाहे बोल कर या लिखित शब्दों में या किसी कार्यकलाप द्वारा छेड़ना, अशिष्टता, असभ्य आचरण द्वारा, उपद्रव के कारण झुंझलाहट, कठिनाई, मनोवैज्ञानिक नुकसान या कोई ऐसे कार्य का प्रदर्शन करने के लिए कहना जो नए या जूनियर छात्रों में डर या शंका पैदा करे या कोई ऐसा कार्य जो छात्र सामान्य जीवन में नहीं करते और जो छात्र के जीवन में शर्मिंदगी या व्याकुलता की भावना पैदा करे या छात्र के जीवन में शारीरिक व मानसिक रूप से विपरीत प्रभाव डाले आदि सभी रैगिंग कहलायेंगे।
