

Feedback Analysis and Action Taken Report (2020-21)

Feedback on curriculum and teaching from students, parents, teachers and alumni is taken every year to analyse the effectiveness of existing curriculum and suggest for any modifications. It also helps to analyse the overall institutional performance in different aspects like administration, library facilities and other activities organized by the college.



Stakeholders feedback helps develop need based inputs in the process of curriculum design and development. The feedback from stakeholders is considered helpful and relevant in improving the curriculum development.

Initiation

The initiation stage includes discussing how the process of feedback will be carried out. The members allocate resources and select an appropriate method to get answers to questions like why do we need the feedback? What resources do we have? Who are we consulting? How will the process be carried out?

Design

The design stage includes constructing the measuring instrument. Questionnaires are an important tool which helps in collecting the data from all the stakeholders.

Administer

The administer stage starts when the stakeholders feedback is actually carried out. It is important at this stage to develop an effective two-way communication with the stakeholders in order to promote open and honest sharing of views and beliefs. The process and data will then need to be accurately recorded for the final stages.

Analysis

The analysis stage is where the data gathered is analysed and reported on. The aim of this stage is to ensure the data is an accurate representation of the stakeholder views, and to prepare the report ready for presentation. The analysis is done by SPSS.

Action Planning

The report is typically presented to the concerned departments where the final stage includes action planning i.e. identifying the weak points and taking steps to improve them.

The feedback obtained from all the stakeholders was analysed on a scale of 1 to 4. The categorization followed based upon the mean score of different parameters i.e. Very Good ($3 \le S \le 4$), Good ($2 \le S \le 3$), Average ($1 \le S \le 2$) and Below Average ($S \le 1$).


Students Feedback and Action Taken Report

- 1. Efficient use of smart classrooms requested by students.
- 2. More information related to career guidance and future options demanded by students.
- 3. Study Material to be made more accessible and should be more organized.
- 4. Course content to be updated keeping in mind the industry requirements.
- 5. Due to on-going pandemic, mentoring programs were also scheduled online. Face to face interaction allow for a more meaningful connection as engagement of mentor-mentee becomes easier. Though students appreciated the efforts of the mentors, but they also demanded for more interaction.

Arts Department

Action to be taken:

1. Teachers have been given proper training on how to use smart classrooms. But due to on-going pandemic, the usage of smart classrooms remained limited this year.

- 2. The college has a placement cell and all activities related to career counselling are performed by it. The requirement regarding the same has been communicated to the cell.
- 3. Teachers make best efforts to provide study material to the students. The department has advised to upgrade to e-library for students as well to make study material more accessible.
- 4. Course content followed is decided by the University. Teachers are timely advised by the Principal to incorporate innovative practices to make their teaching pedagogy broader.

Commerce Department

Action to be taken:

- 1. For better results, Power Point Presentations to be uploaded on the online portal.
- 2. The Placement cell has been advised to be more responsive to students' needs in these unprecedented times.
- 3. Through 'Add-on' courses, the college plans to prepare students to the emerging needs of times.
- 4. The suggestion given by students for success of mentoring was taken into consideration.

Science Department

Action to be taken:

- 1. PowerPoint Presentations prepared by college teachers have been uploaded on the online portal for easy access of study material. Lecture recordings if needed can be made available to students in the upcoming sessions.
- 2. With starting of offline classes, teachers will be trained to get accustomed to smart classrooms to make learning more effective and practical.
- 3. The Placement Cell has been advised to conduct more workshops in online/offline mode to help students have a greater clarity related to their future.
- 4. Students will be given extra guidance if the need be.

BCA Department

Action to be taken:

- 1. Teachers have been advised to provide compact and compiled study material to students which will help them in preparing for exams in COVID-19 times, specifically when classes were taken online. Also secondary study material has been made available in the library.
- 2. Follow up sessions to be recommended to make mentor-mentee relationship more successful.
- 3. More training to be given to teachers for use of smart classrooms.
- 4. The suggestion for more career counselling has been forwarded to placement cell. The cell has been advised to conduct more seminars and workshops to enable the students to gain insight into industry requirements.

Action taken at institution level on the basis of suggestion from students:

- 1. All the departments have been advised to divide students into small groups and have an interaction with them in assigned time to provide mentorship. This helps teachers to address student's complaints/doubts or any other difficulty they might be experiencing in the college.
- 2. Suggestion boxes/Grievance Redressal boxes have been made available at all convenient places. Students are timely encouraged to provide suggestions to help ensure smooth functioning of the college.


Parents Feedback and Action Taken

Action to be taken:


- 1. Online PTM was organised in the last semester as a temporary solution in the pandemic. The college plans to organize offline PTM in the upcoming year to ensure same interaction as before with the parents.
- 2. The college follows the curriculum designated by the University. Teachers will also be advised to make the teaching learning process more inclusive and discussion based to be in synchronisation with the industry standards. The concern has been shared with placement cell so that appropriate action can be taken.
- 3. Due to ongoing pandemic, students and parents had issue with online classes and offline exams. Offline classes will be planned soon so as to enable students to have better understanding of the syllabus.

Action to be taken:


