This Memorandum of Understanding is signed on 6th August 2022 at Faridabad, Haryana and is made between

- 2. Activities: The parties agree to work together to organize and carry out various activities, including but not limited to, blood donation camps, skill development programs for women, awareness lectures on social issues, health and hygiene awareness drives, and other community development projects. The specific activities to be carried out under this MOU shall be identified and agreed upon by the parties on a case-by-case basis.
- 3. **Responsibilities**: The Rotary Club shall be responsible for organizing and conducting the activities in collaboration with the College. The College shall provide support to the Rotary Club in organizing the activities and shall encourage its students and faculty to participate in the same. The Rotary Club shall bear the expenses of organizing the activities, including but not limited to, the cost of organizing the blood donation camps, setting up the skill development centres, conducting awareness lectures, and other community development projects.
- 4. **Funding:** The Rotary Club shall bear the expenses of organizing the activities, including but not limited to, the cost of organizing the blood donation camps, setting up the skill development centres, conducting awareness lectures and other community development projects.
- 5. **Duration:** This MOU shall be valid for a period of one year, commencing from the date of signing of this MOU, and may be extended by mutual consent of the parties.
- 6. **Termination:** Either party may terminate this MOU by giving 20days prior written notice to the other party.

- 7. Confidentiality: The parties shall maintain the confidentiality of all information exchanged under this MOU and shall not disclose it to any third party without the prior written consent of the other party.
- 8. Governing Law: This MOU shall be governed by and construed in accordance with the laws of the state of India.
- 9. Liability: The parties shall not be liable to each other or to any third party for any indirect, incidental, consequential, or punitive damages arising out of or in connection with this MOU, except in cases of willful misconduct or gross negligence
- 10. Signatures: This MOU may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.
